Why you or your institution should set up a Test Center

Many Institutions – academic and non-academic - are drafting new Digital Curricula, based on the **European Digital Competences Framework**, Dig Comp 2.2. Setting-up an EDSC Test Center means offering candidates the opportunity to certify their digital skills, which are useful for their personal curriculum, as educational credit for the State’s Examination, and spendable for an increasingly competitive labour market.

How to set up a Test Center

- The Institution/Establishment will need to **fill out the pre-accession form**, "EDSC Dig Comp 2.2 Test Center", with its master data;
- Skill on Line will train and certify **two "EDSC Proctor" teachers** from the school, with both Dig Comp Edu learning materials and Proctor training path. They will be in charge of the teaching of the Dig Comp Edu course and they will be the contact persons for all activities related to EDSC Dig Comp 2.2 certification: organization, technical support, activation of exam sessions and technical-managerial consultations;
- The adhesion will be confirmed at the end of the Proctor course, upon minimum purchase of 100 KIT Mi certificado Dig Comp 2.2".

Each KIT "Mi certificado Dig Comp 2.2" includes:

- 1 access to Dig Comp 2.2 student training content on the Aula01 digital platform, for 12 months
 - 1 exam voucher for EDSC Dig Comp 2.2 certification.
 - EDSC Dig Comp Test Center Accreditation.
- The Institution will activate certification exam sessions onsite, with the presence of a Dig Comp 2.2 certified Proctor. The supervision activity at the exam session will be paid by Skill on Line directly to the Proctor;
 - The school will have to provide a computer room equipped with an Internet connection and a PC for each student;
 - The certification exams will be held online, exclusively on the platform of Intertek, accompany that is accredited by Accredia. A certificate will be issued both in PDF and in personal Open Badge format. Each certificate is verifiable on Accredia's Public Register.
 - The school will receive the "EDSC Dig Comp 2.2" plaque as an onsite Test Center.
